THE PEOPLES DEMOCRATIC PARTY (PDP) (Election of Party Official and Nomination of Party Candidates) RULES

(Under Chapter 4 and 6 of the Peoples Democratic Party Constitution)

PRELIMINARY

(i) These rules may be cited as The Peoples Democratic Party (PDP) (Election of party officials and Nomination of party candidates) rules.

(ii) In these rules, unless the context otherwise dictates;

“Branch” means a branch established under the party constitution

“Constitution” means constitution of the party

“Director of Elections” means the Director of Elections appointed under the constitution

“Electoral Commission” means the electoral commission of Kenya

“National Delegates Convention” means the national delegates convention of the party established under the constitution

“Party” means the Peoples Democratic Party – PDP

“Party Leader” means the party leader elected in accordance with the constitution

“Rule” means any of these rules

“Subscriber” means a person other than the applicant, whose name and signature is required in a nomination application paper.

Words importing the masculine gender only, include also the feminine gender

Words importing the singular number only, include also the plural number

(iii) Any paid up Life Member of the party shall have the right to offer himself or herself to be nominated as a candidate for the party during any party nominations or elections

NATIONAL ELECTIONS BOARD

There shall be established by the National Executive Committee (NEC) before the commencement of the party's Elections and Primaries for any Presidential, Gubernatorial, Senatorial, County Woman M.P Parliamentary or County Assembly Elections, a National Elections Board as per *article 6.5* of the Party Constitution.

Article 6.5 of the Party's Constitution.

- i) *There is hereby established the Peoples Democratic Party National Elections Board whose mandate is to plan, organize, direct and coordinate the Peoples Democratic Party Internal Party Elections and the Peoples Democratic Party Presidential, Gubernatorial, Senatorial, County Woman M.P Parliamentary or County Assembly Elections of candidates throughout the Republic of Kenya, in readiness for General Elections or By-Elections.*
- ii) *The National Elections Board will be appointed by the National Executive Committee from the shortlisted applicants upon a resolution made by two thirds of members and will comprise seven respected and knowledgeable persons of high integrity who do not hold any elective Party position, One member should represent special interest group (SIC) and at least one third shall be either of gender.*
- iii) *The National Election Board shall comprise a Chairperson and Deputy Chairperson either of whom shall be an Advocate of the High Court of Kenya of not less than ten years standing and five other members. Both the Chairperson and Deputy Chairperson shall be appointed by the National Executive Committee.*
- iv) *The National Election Board Members shall be persons who are Kenyan Citizens, Life members of the Party, Signs Code of conduct and certifies chapter six of the Kenyan Constitution.*
- v) *The National Election Board Member(s) shall ceases to be a member if he/she gives a 21 days written resignation notice to the NEC, Ceases to be Kenyan Citizens, Ceases to be a Life members of the Party, acting against Signed Code of conduct and contravening any or all chapter six requirements of the Kenyan Constitution.*
- vi) *The National Elections Board shall make its own rules of procedure for its meetings but the National Executive Committee shall make Nomination Rules and Regulations to be approved by the National Governing Council.*
- vii) *The National Secretariat shall provide secretarial support services to the Board.*
- viii) *The members of the National Elections Board may serve for a term of five years and are eligible for re-appointment at the expiry of their term, subject to a maximum of two consecutive terms.*

(a) Duties, Functions and Mandate of *National Elections Board*:

- (i) The National Election Board shall supervise Party Nominations and shall in particular give notice to all branches of an impending Nominations exercise and shall prepare and disseminate to all branches a timetable for the conduct and completion of nominations of the party candidates before any election(s).
- (ii) The National Election Board shall appoint a Returning Officer for each branch and may appoint such deputy returning officers for the branches as it may, after consultations with the relevant Branch Nominations Committee, consider necessary.
- (iii) The National Election Board shall Monitor and enforce the code of conduct for the candidates.
- (iv) Decisions of The National Election Board shall be by simple majority
- (v) The quorum for the National Election Board meetings shall be two thirds and they can meet as many times as the need arises.
- (vi) The National Election Board shall on recommendation of the Branch Nominations Committee designate a place(s) at which the nomination polling station(s) for each branch, sub-branch and ward shall be established.
- (vii) The National Election Board shall establish Branch Nominations Committee in every branch
- (viii) The National Election Board shall appoint a chairperson from amongst members of Branch Nominations Committee

(b) BRANCH ELECTION & NOMINATIONS COMMITTEE

- (i) There shall be established Branch Nominations Committee in every branch which shall consist of seven members of good standing and irreproachable integrity themselves not seeking Elective position or Nomination as party's official or candidates and having no connection to any candidate for Election or nomination as would put their impartiality into question.
- (ii) The members of the Branch Nominations Committee shall be selected by the National Election Board from amongst shortlisted applicants which shall also appoint a chairperson from amongst such members.

(bb) Duties, Functions and Mandate of Branch Election & Nominations Committee:

- (i) The Branch Election & Nominations Committee shall on the same day or days appointed by the National Election Board conduct nominations for the party Gubernatorial, Senatorial,

county women M.P candidates at the branch and party parliamentary and county assembly elections candidates at the sub-branches within the branch.

- (ii) The Branch Election & Nominations Committee may be consulted by the National Election Board before the Board appoints a Returning Officer for each branch and may appoint such deputy returning officers for the branches as it may consider necessary.
- (iii) The Branch Election & Nominations Committee shall recommend to the National Election Board the designated place(s) at which the nomination polling station(s) for each branch, sub-branch and ward shall be established.
- (iv) The Branch Election & Nominations Committee shall appoint a Presiding Officer to preside at a polling station who may be assisted by such deputy presiding officers as the Branch Election & Nominations Committee may consider necessary except that no person shall be so appointed to preside at a nomination poll if he has been employed by or on behalf of, or has in any manner whatsoever assisted any candidate in or about that nomination exercise.

PART I - ELECTION OF NATIONAL AND OTHER PARTY OFFICIALS

Part I (a) ELECTION OF NATIONAL OFFICIALS.

- (i) National Delegates Convention (NDC) shall consist of such number of elected delegates from each County/Branch in Kenya, as per the Party Constitution
- (ii) Quorum of ordinary or special sessions of National Delegates Convention convened for purposes of election shall be *Two Thirds* of eligible members.
- (iii) The Notice and Agenda of election of National Officials convening the ordinary session of National Delegates Convention shall be sent by the Secretary General at least three (3) weeks before such date and published on the digital platform.
- (iv) Where a special session of the NDC requisitioned for purposes of election of all or part of national official the notice shall not be less than twenty-one working days provided that such notice shall contain the positions to be filled through an election, place, date and time for the convention.
- (v) Any legitimate member of the National Delegates Convention as per party constitution is qualified to contest for any of the National Office position if he/she satisfies the National Election Board requirements
- (vi) The National Election Board shall receive applications and signed party code of conduct from all applicants for various positions and prepare for elections during the ordinary or special National Delegates Convention.
- (vii) All National officials shall be elected by the National Delegates Convention and shall hold office for a term of five years. Provided that when desirable Special NDC may declare and hold elections for all or part of the National Officials the new National Officials under the

revised Constitution shall be in office for a period of seven years, hereby the transitional period.

- (viii) Any National official deemed to be grossly indiscipline and or acting in direct contravention to the party's object shall be removed from office by a resolution of at least two third majority of the National Executive Committee which shall be ratified by the National Governing Council.
- (ix) Election shall be through secret ballot or any other method of voting acceptable to the delegates in session.
- (x) Elections in every case shall be conducted between the hours of 9:00am to 4:00pm
- (xi) A situation where an office is contested by more than one candidate, the vote shall be decided by a simple majority.
- (xii) Where only one candidate is nominated to an office at the close of the nominations, the candidate shall be declared duly elected to the office for which he/she was nominated.
- (xiii) Application for Nominations of all candidates shall be in the prescribed *FORM PDP NDC1 (a)*
- (xiv) The Secretary for Youth Affairs shall not be more than 35 years of age at the time of election irrespective of gender.
- (xv) The secretary for women affairs shall be a female.
- (xvi) The secretary for PLWD affairs shall be a person living with disability.

Part I (b) ELECTION OF BRANCH OFFICIAL

- (i) Branch Delegates Convention (BDC) shall consist of such number of elected delegates as per the Party Constitution from each Constituency in a particular County/ Branch.
- (ii) Quorum of ordinary or special sessions of Branch Executive Committee (BEC) convened for purposes of election shall be *Two Thirds* of eligible members.
- (iii) The Notice and Agenda of Election of Branch Executive Committee (BEC) convening the ordinary session of Branch Delegates Convention (BDC) shall be sent by the Branch Executive Officer. At least three (3) weeks before such date and copied to the Secretary General
- (iv) Where a special session of the BDC requisitioned for purposes of Election of all or part of Branch Executive Committee (BEC) the notice shall not be less than twenty-one working days provided that such notice is okayed by the Secretary General and shall contain the positions to be filled through an Election, place, date and time for the meeting.
- (v) Any legitimate member of the Branch Delegates Convention (BDC) as per party constitution is qualified to contest for any of the Branch Executive Committee (BEC) position if he/she satisfies the National Election Board requirements
- (vi) The Branch Election & Nomination Committee shall receive applications and signed

party code of conduct from all applicants for various positions and prepare for Elections during the ordinary or special Branch Delegates Convention (BDC).

(vii) All Branch Executive Committee (BEC) shall be elected by the Branch Delegates Convention (BDC) and shall hold office for a term of five years. Provided that when desirable Special BDC may declare and hold elections for all or part of the Branch Executive Committee (BEC) the new Branch Executive Committee (BEC) under the revised Constitution shall be in office for a period of seven years, hereby the transitional period.

(viii) Any Branch Executive Committee (BEC) deemed to be grossly indiscipline and or acting in direct contravention to the party's object shall be removed from office by a resolution of at least two third majority of the Branch Executive Committee (BEC) which shall be ratified by the National Executive Committee.

(ix) Election shall be through secret ballot or any other method of voting acceptable to the delegates in session.

(x) Elections in every case shall be conducted between the hours of 9:00am to 4:00pm

(xi) A situation where an office is contested by more than one candidate, the vote shall be decided by a simple majority.

(xii) Where only one candidate is nominated to an office at the close of the nominations, the candidate shall be declared duly elected to the office for which he/she was nominated.

(xiii) Application for Nominations of all candidates shall be in the prescribed *FORM PDP BDC1 (b)*

(xiv) The Secretary for Youth Affairs shall not be more than 35 years of age at the time of election irrespective of gender.

(xv) The secretary for women affairs shall be a female.

(xvi) The secretary for PLWD affairs shall be a person living with disability.

Part I (c) ELECTION OF SUB- BRANCH OFFICIAL

(i) Sub-Branch Delegates Convention (SBDC) shall consist of such number of elected delegates as per the Party Constitution from each ward in a particular Constituency / Sub Branch.

(ii) Quorum of ordinary or special sessions of Sub-Branch Executive Committee (SBEC) convened for purposes of election shall be *Two Thirds* of eligible members.

(iii) The Notice and Agenda of Election of Sub-Branch Executive Committee (SBEC) convening the ordinary session of Sub-Branch Delegates Convention (SBDC) shall be sent by the Branch Executive Officer. At least three (3) weeks before such date and copied to the Secretary General

(iv) Where a special session of the SBDC requisitioned for purposes of Election of all or part of Sub-Branch Executive Committee (SBEC) the notice shall not be less than twenty-one working days provided that such notice is Okayed by the Secretary General and shall contain the positions to be filled through an Election, place, date and time for the meeting.

- (v) Any legitimate member of the Sub-Branch Delegates Convention (SBDC) as per party constitution is qualified to contest for any of the Sub-Branch Executive Committee (SBEC) position if he/she satisfies the National Election Board requirements
- (vi) The Branch Election & Nomination Committee shall receive applications from all applicants for various positions and prepare for Elections during the ordinary or special Sub-Branch Delegates Convention (SBDC).
- (vii) All Sub-Branch Executive Committee (SBEC) shall be elected by the Sub-Branch Delegates Convention (SBDC) and shall hold office for a term of five years. Provided that when desirable Special SBDC may declare and hold elections for all or part of the Branch Executive Committee (BEC) the new Branch Executive Committee (BEC) under the revised Constitution shall be in office for a period of seven years, hereby the transitional period.
- (viii) Any Sub-Branch Executive Committee (SBEC) deemed to be grossly indiscipline and or acting in direct contravention to the party's object shall be removed from office by a resolution of at least two third majority of the Sub-Branch Executive Committee (SBEC) which shall be ratified by the Branch Executive Committee (BEC)
- (ix) Election shall be through secret ballot or any other method of voting acceptable to the delegates in session.
- (x) Elections in every case shall be conducted between the hours of 9:00am to 4:00pm
- (xi) A situation where an office is contested by more than one candidate, the vote shall be decided by a simple majority.
- (xii) Where only one candidate is nominated to an office at the close of the nominations, the candidate shall be declared duly elected to the office for which he/she was nominated.
- (xiii) Application for Nominations of all candidates shall be in the prescribed *FORM PDP SBDC1 (c)*
- (xiv) The Secretary for Youth Affairs shall not be more than 35 years of age at the time of election irrespective of gender.
- (xv) The secretary for women affairs shall be a female.
- (xvi) The secretary for PLWD affairs shall be a person living with disability.

Part I (d) ELECTION OF WARD OFFICIAL

- (i) The a foregoing rules regarding the Election of the Sub-Branch Executive Committee Official shall apply mutatis mutandis to the election of party Ward officials.
- (ii) Ward Delegates Convention (WDC) shall consist of such number of elected delegates from each Polling Center in a particular ward.
- (iii) All registered party members are legible to vote and be voted for as a delegate from the polling Centre.

PART II - PARTY NOMINATIONS RULES AND PROCEDURES (PRIMARIES).

(a) PARTY PRESIDENTIAL CANDIDATE

- (i)** The party presidential candidate shall be a member duly elected by the National Delegates' Convention in accordance with the constitution.
- (ii)** Every candidate for nomination as the party presidential candidate shall on the day designed by the National Election Board deliver to the said Board a nomination application papers in the prescribed form. *Form PDP1(a)*
- (iii)** The Nomination application paper shall be completed in triplicate and delivered to the National Election Board together with a pledge of commitment in the prescribed form sworn before a Commissioner for Oaths not earlier than two weeks before the designed day. *FORM PDP 2 (a)*
- (iv)** The nomination application paper shall contain in relevant part the Names, Signatures and Electoral numbers descriptions of the person proposing the candidate for nomination; the person seconding the proposition and one hundred party members in each county (at least twenty four counties).
- (v)** The subscribers to the nomination application paper shall be members of the party who are registered as electors for the County they are proposing from.
- (vi)** Every application for nomination as the presidential candidate shall be accompanied by such non-refundable nomination fee as shall be prescribed by the National Executive Committee (NEC) *Fourth Schedule*:
- (vii)** No person shall qualify to be nominated as a presidential candidate unless he/she satisfies the National Elections Board and the Returning Officer on the nomination day that;
 - (a)** He has a valid party life membership card
 - (b)** He has signed and commissioned party code of conduct.
 - (c)** He has an elector's card / acknowledgement in any constituency in the republic of Kenya
 - (d)** He has a National Identity Card or a Kenya passport.
 - (e)** He is qualified by law for being elected as president
- (viii)** The National Election Board shall make a decision on the validity of a nomination application forthwith.
- (ix)** If, after the closure of the time set for applying for nomination no valid application is received, and unless the National Election Board considers it fit to order a repeat of

nominating the chairman of National Election Board shall execute the requisite certificate and countermand the participation of the party in the elections of president.

(x) If, after the close of the time set for the making of applications for nomination, only one valid application is received, the National Election Board shall declare the candidate who made that application to be nominated as the party candidate and shall execute the requisite certificate in the prescribed form.

(xi) If, after the close of nominations, two or more candidates satisfy all the criteria for a valid application, the National Elections Board shall, publish the names of the candidates for the nomination and shall give notice of the situation to each branch for purposes of a poll to determine the party candidate on a date and time determined or to be determined by the National Elections Board. In every case the nominations shall be conducted between the hours of 9:00am to 4:00pm.

(xii) The poll shall be by secret ballots cast by national Delegates Convention of the party provided that no delegate shall cast more than one vote at any particular poll.

(xiii) The returning officer shall ensure sufficiency of the ballot papers and indelible ink as well as sufficient facilities for the voters to mark their votes unobservable

(b) – PARTY GUBERNATORIAL, SENATORIAL, COUNTY WOMEN M.P AND PARLIAMENTARY CANDIDATES

(i) Every candidate for Nomination as the party Gubernatorial, Senatorial, County Women M.P and Parliamentary candidate shall on the day designed by the National Election Board deliver to the said Board a nomination application paper in the prescribed format. *FORM PDP 1 (b) & (c)*

(ii) The Nomination application paper shall be completed in triplicate and delivered to the National Nominations Committee together with a pledge of commitment in the prescribed form sworn before a Commissioner for Oaths not earlier than two weeks before the designated day. *FORM PDP 2 (b) & (c)*

(iii) The nomination application paper shall contain in relevant part the Names, Signatures and Electoral numbers descriptions of the person proposing the candidate for nomination; the person seconding the proposition and one hundred supporters for the county seat and fifty for a parliamentary position of the candidate for nomination.

(iv) The subscribers to the nomination application paper shall be members of the party who are registered as electors for the County/ constituency comprising the branch /sub branch.

(v) Every application for nomination as the party Gubernatorial, Senatorial, County Women M.P Parliamentary candidate shall be accompanied by such non-refundable nomination fee as shall be prescribed by the National Executive Committee (NEC) *Fourth Schedule:*

(vi) No person shall qualify to be nominated as a party Gubernatorial, Senatorial, County Women M.P and Parliamentary candidate unless he satisfies the National Elections Board and the Returning Officer on the nomination day that;

- a. He has a valid party life membership card
- b. He has signed and commissioned party code of conduct.
- c. He has an elector's card in any constituency in the republic of Kenya
- d. He has a national identity card or a Kenya passport.
- e. He is qualified by law for being elected as an elected member of the position he or she is contesting.

(vii) The National Election Board shall make a decision on the validity of a nomination application forthwith.

(viii) If, after the closure of the time set for applying for nomination no valid application is received, and unless the National Election Board considers it fit to order a repeat of nominating the chairman of National Election Board shall execute the requisite certificate and countermand the participation of the party in the elections in the Electoral area concerned.

(ix) If, after the close of the time set for the making of applications for nomination, only one valid application is received, the National Election Board shall declare the candidate who made that application to be nominated as the party candidate and shall execute the requisite certificate in the prescribed form.

(x) If, after the close of nominations, two or more candidates satisfy all the criteria for a valid application, the National Elections Board shall, publish the names of the candidates for the nomination and shall give notice of the situation of each polling station for purposes of a poll to determine the party candidate on a date and time determined or to be determined by the National Elections Board. In every case the nominations shall be conducted between the hours of 8am to 5pm.

(xi) The poll shall be by secret ballots cast by members of the party who are registered in the electoral area comprising the branch/ sub branch provided that no person shall cast more than one vote at any particular poll.

(xii) The returning officer shall ensure sufficiency of the ballot papers and indelible ink as well as sufficient facilities for the voters to mark their votes unobservable.

(xiii) The presiding officer shall in conjunction with the Branch Nominations Committee regulate the number of electors to be admitted into the polling station at a given time and shall in particular exclude all other persons except those whose presence is strictly necessary for the smooth and secure conduct of the marking and casting of votes.

(xiv) The presiding officer shall admit to the polling station an agent of each candidate upon production by such agent of a letter of appointment as an agent duly signed by the candidate.

(xv) The presiding officer shall in conjunction and consultation with the Branch Nominations Committee keep order at his polling station and may order any person that misconducts himself or otherwise obstruct the smooth conduct of the poll to be removed or dispersed there from.

(xvi) A presiding officer may, with the concurrence of the Returning Officer and the Branch Nominations Committee, postpone, adjourn or transfer the proceedings at his polling station where they are interrupted by a riot, open violence, flood, natural catastrophe or other compelling reason provided that he shall thereafter start or re-start the proceedings expeditiously at the earliest practical moment.

(xvii) Every party member eligible to vote at the party nominations poll shall do so by secretly marking the ballot paper issued to him designating the candidate of his choice and casting it into the ballot box provided for that purpose where after he shall immediately leave the polling station.

(xviii) The Presiding Officer shall before issuing a ballot paper to a voter first ascertain that the said person is validly registered as a voter at that polling station and on a ballot paper being delivered to the voter the presiding officer shall cause a mark to be placed in the copy of the voters register to denote issuance of such ballot.

(xix) Immediately after the close of the poll the presiding officer shall, in the presence of the candidate(s) or their previously appointed counting agents begin to sort & count the votes for each candidate and record in prescribed form then the agents present signs as witness.

(xx) The Returning Officer shall receive and aggregate the results as received from the presiding officer(s) then declare the person with the highest tally as the duly nominated.

(xxi) A candidate or a counting agent lawfully present at the counting may require having the votes rechecked and recounted provided that there shall not be more than two recounts of the votes.

(xxii) After the conclusion of the counting of votes including a re-count, the Returning Officer shall declare the candidate with the highest number of total votes in the Branch/ Sub branch as duly nominated as the party candidate and shall execute and deliver the requisite certificate to that effect to the National Election Board. *Form PDP 3 (a)& (b)*

(c) PARTY MEMBER OF COUNTY ASSEMBLY CANDIDATES

The a foregoing rules regarding the nomination of the party Gubernatorial, Senatorial, County woman M.P and Parliamentary candidate shall apply mutatis mutandis to the nomination of the party County assembly candidate provided that the application shall be to the Branch Nomination Committee in *Form PDP1 (d)* and the number of supporters who shall subscribe to the nomination application paper under rule part III (b) (iii) shall be Ten.

(d) PARTY LIST NOMINATIONS for SENATORIAL and PARLIAMENTARY

- (i)** Every candidate for Nomination as the party Senatorial and Parliamentary candidate shall on the day designed by the National Election Board deliver to the said Board a nomination application paper in the prescribed format. *FORM PDP 1 (b) & (c)*
- (ii)** The Nomination application paper shall be completed in triplicate and delivered to the National Election Board together with a pledge of commitment in the prescribed form sworn before a Commissioner for Oaths not earlier than two weeks before the designated day. *FORM PDP 2 (b) & (c)*
- (iii)** The Nomination application paper Every application for nomination as the party Senatorial and Parliamentary candidate shall be accompanied by such non-refundable nomination fee as shall be prescribed by the National Executive Committee (NEC)

Fourth Schedule:

(iv) The Nomination application paper shall contain in relevant part the Names, Signatures and Electoral numbers descriptions of the person proposing the candidate for nomination; the person seconding the proposition

(v) No person shall qualify to be nominated as a party Senatorial, and Parliamentary candidate unless he satisfies the National Elections Board and the Returning Officer on the nomination day that;

 - (a)** He has a valid party life membership card
 - (b)** He has signed and commissioned party code of conduct.
 - (c)** He has an elector's card in any constituency in the republic of Kenya
 - (d)** He has a national identity card or a Kenya passport.
 - (e)** He is qualified by law for being elected as an elected member of the position he or she is contesting.

(vi) The National Election Board shall make a decision on the validity of a Nomination application forthwith and forward a shortlisted list to the National Executive Committee (NEC)

(vii) The National Executive Committee (NEC) shall make determination on the final list by a simple majority vote or consensus

(viii) The secretary shall forward the list to the Independent Electoral and Boundaries Commission (IEBC) signed by the signatories of the Nomination Certificate

(f) PARTY LIST NOMINATIONS FOR MEMBER OF COUNTY ASSEMBLY.

- (i)** The a foregoing rules regarding the nomination of the party list for Senatorial, Parliamentary candidate shall apply mutatis mutandis to the Nomination of the party List candidate for member of the county assembly.
- (ii)** The Nomination application paper shall be completed in triplicate and delivered to the National Election Board together with a pledge of commitment in the prescribed form sworn before a Commissioner for Oaths not earlier than two weeks before the designated day.
FORM PDP 2 (d)
- (iii)** Every application for nomination as the party list candidate shall be accompanied by such non-refundable nomination fee as shall be prescribed by the National Executive Committee (NEC) *Fourth Schedule*:
- (iv)** The Branch Nomination Committee shall make a decision on the validity of a Nomination application forthwith and forward a shortlisted list to the National Executive Committee (NEC)
- (v)** The National Executive Committee (NEC) shall make determination on the final list by a simple majority vote or consensus
- (vi)** The secretary shall forward the list to the Independent Electoral and Boundaries Commission (IEBC) signed by the signatories of the Nomination Certificate

PART IV – NOMINATION DISPUTE RESOLUTION

- (i)** There shall be established a National Nominations Appeals Committee which shall comprise of five members of the party nominated by the National Executive Committee PROVIDED that such persons shall meet the same qualifications as prescribed herein for membership of The National Elections Board. One member should represent special interest group (SIC) and at least one third shall be either of gender. The National Executive Committee shall nominate a chair from amongst the five members of the National Nominations Appeals Committee.
- (ii)** The National Nominations Appeals Committee shall make its own rules of procedure for its meetings and shall operate independently of other party organs.
- (iii)** Any candidate for Nomination who is dissatisfied with the conduct or result of the nomination may appeal in writing to the national nomination appeals committee setting out the grounds of grievance which appeal shall be lodged at the party Headquarter within three days of the nomination complained of upon payment of such non-refundable fee as shall be prescribed by the National Executive Committee.
- (iv)** The National Appeals Committee shall consider the appeal and all the evidence and material tendered in support of the same whereupon it shall render its decision within

three days of the receiving the appeal. Such decision shall be by a majority of the members of the committee.

(v) The National Nominations Appeals Committee may in its decision;

- (a) Allow the appeal in which case the nomination made shall be annulled and a repeat nomination ordered or
- (b) Dismiss the appeal thereby affirming the nomination appealed from.

(vi) The decision of The National Nominations Appeals Committee on an appeal shall be final.

PART V – NOMINATION CERTIFICATES

- (a) Nomination Certificates to the Independent Electoral and Boundaries Commission of Kenya shall be duly prepared by the Executive Director using “*FORM PDP 3*” and presented to the candidates after being duly signed by the Secretary General whose signature will mandatory and one other member of the National Election Board or NEC as will be authorized by the resolution of the National Executive Committee.
- (b) The party Secretary General shall certify to the electoral commission the names and particulars of the party candidate. All certificates shall, in accordance with article 5.3.3(e) of the Party Constitution be retained in the custody of the party’s Secretary General.

PART III CODE OF CONDUCT

The party shall be guided by the code of conduct both for the party and its candidates and the operations shall be monitored and enforced by the National Election Board and its Devolved structures subject to approval of a simple majority of the NEC membership.


